## "Hot Flashes and Cool Revelations: Dispelling Myths about Hormone Replacement Therapy and Breast Cancer"

**Program Summary:** In this "mock" podcast (JALBCA Health podcast), legal and medical experts will explore a new perspective on Hormone Replacement Therapy (HRT) and breast cancer risk. Legal experts Caroline Brancatella, Esq., and Danielle Tangorre, Esq., will analyze a fictional scenario involving a social media influencer working in conjunction with a NY licensed physician to sell and promote "Serenity Now," a product that is not FDA approved and is advertised and sold to all 50 states. Pierette claims that her product treats the symptoms of menopause and peri-menopause without increasing the risk of breast cancer. The legal experts will explain both the civil and criminal consequences for Pierrette and the physician under NY law. This includes a framework for understanding how NY defines and regulates the unauthorized practice of law, professional misconduct, as well as FDA labeling, communications and off label use, regulation of advertising and exemplary social media posts, corporate practice, and the Federal Trade Commission's role. The medical experts will explain the use of HRT for menopause and peri-menopause, symptom management, treatment options and the latest data on the breast cancer risk relating to HRT.
